With two active gas wells generating income and Seller's mineral ownership transferring to Buyer, it presents an attractive investment. Located near Cimarron National Grassland and the Cimarron River, the land is rich in wildlife, including deer, quail, and pheasants.

Land

This 320-acre property offers a unique investment opportunity with multiple income streams and natural features. Of the 320 acres, 112.94 acres consists of pasture land while the additional 207.06 acres were just re-enrolled into CRP and has an annual payment of \$6256.00 and expires September 30, 3034. In addition, the property is well-suited for the Walk-In Hunting Program or private hunting leases, providing the potential for further income.

There are two active gas wells on the property, one in operation since 1990 and the other since 2010. In 2023, the seller earned approximately \$2,900 from gas production. Importantly, the seller's mineral rights will transfer to the buyer, a rare advantage in a region once known as the gas capital of the world. A powerline comes through the middle of the property as well. Located just 3.5 miles north of the Cimarron National Grassland and a quarter-mile west of the Cimarron River, the property boasts excellent wildlife habitat, including mule deer, whitetail deer, antelope, bobwhite quail, pheasants, and various predators.

 turn left onto Rd Y and you reach the property in ½ mile.
- From Rolla/US-56, head north on KS-51 to 23 Rd for 10 miles. Then continue onto 23rd for 5 miles then turn right onto Z rd. In 7 miles, turn right onto Rd 3 and then in 1 mile turn left onto Rd Y and you reach the property in ½ mile.


