This 320 +/- acre property offers a well-balanced mix of productive farmland and CRP acreage, making it an attractive investment for agricultural operations. The land consists of just under 71 acres enrolled in the Conservation Reserve Program (CRP) and 249 acres of tillable land. Of the tillable acreage, 80 acres in the northern section are currently planted with milo, 87 acres in the middle section are planted with wheat, and the southern 76 acres are in stubble, ready to be planted. Tillable acres are class II and Class III, with a NCCPI of 60.38.

The property is easily accessible via good roads along both the south and east sides. Its prime location is just 1 mile from Highway 4, providing quick access to nearby elevators. The property is 7 miles from the Shields elevator and 8 miles from the Utica elevator, offering convenient transportation routes for crops.

With a solid yield history, the land has produced quality wheat and milo in the past. This property offers an excellent opportunity for farming operations looking for productive land as well as access to grass for cattle to graze. Income from both the CRP contract as well as additional income with the lease of the grass for cattle grazing.


