

This well-maintained 5-bed, 2-bath bi-level home in Ord, NE, offers a spacious and functional layout with ample living and storage space. Original hardwood floors and stained trim add character and warmth. The lower level includes another sizable living space, two bedrooms, a full bath, more storage closets, and a large utility room with laundry, water softener, and Lennox furnace with incorporated humidifier. The home has a 200-amp panel in the attached garage, a cleanly landscaped yard, and a large backyard —perfect for kids, pets, and outdoor gatherings. Built in 1970, it has been well-maintained with a furnace and heat pump installed in 2018, a new roof in 2023, and updated kitchen appliances and garbage disposal in 2023, all of which stay. The all-electric home averages \$180/month for utilities with Ord Light and Water. A fantastic opportunity for space, comfort, and convenience in a great location!

Ord, Nebraska, offers a variety of recreational activities and outdoor experiences for visitors and residents. Highlights include Calamus Reservoir State Recreation Area for boating, fishing, and camping, and the Valley County Fairgrounds for rodeos and community events. Outdoor enthusiasts can enjoy Auble's Pond for fishing, the North Loup River for kayaking and tubing, and hiking trails in the Sandhills region. The town features a 9-hole golf course, local parks like Bussell Park, the Ord Aquatic Center & Splash Pad and excellent hunting opportunities. Nearby, Nebraska's Big Rodeo in Burwell attracts rodeo fans. Ord also hosts cultural events, farmers' markets, and seasonal festivals, making it a welcoming destination for outdoor and community activities.


